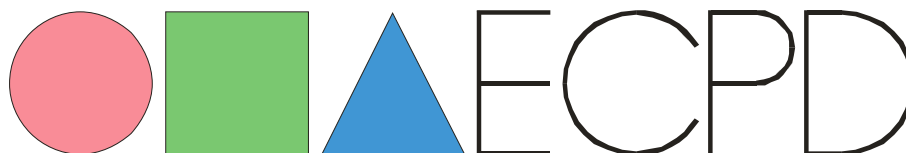
**INTEGRATED HEALTH SYSTEM
